Village of Holmen Law Enforcement Committee May 7, 2019

The meeting of the Holmen Law Enforcement Committee was held Tuesday May 7, 2019, in the Village Hall board room.

Chair Dawn Kulcinski called the meeting to order at 6:06pm.

Present at the meeting: Committee members Dawn Kulcinski, Doug Jorstad, and Rodney Stanek. Also in attendance were Administrator Scott Heinig and Chief Shane Collins.

Approval of Minutes Doug Jorstad and Rodney Stanek motioned to approve the minutes of the March 5, 2019 meeting. The motion carried unanimously.

Present Monthly Activity The Committee reviewed all monthly activity for March and April.

Present Monthly Claims The Committee reviewed monthly claims for March and April.

Municipal Court Update Collins advised Heinig was voted Vice Chair and Teresa Schnitzler was voted Chair. The rest of meeting was general information.

Discussion/Possible Action Recommendation on Kids Again Inflatables Rental for NNO
Collins advised the price for the inflatables will be \$4725.00. Collins advised this price is up one thousand dollars from last year because the Legion is sponsoring an additional inflatable this year and will donate a \$1000.00 towards the inflatable. Stanek asked if this was a budgeted item. Collins advised this is a budgeted item along with a lot of donations the Police Department receives. Committee motioned unanimously to recommend to the Board for the approval of renting the Kids Again Inflatables for the price of \$4725.00.

ADDITIONAL INFORMATION Collins advised last year there was a lot of drug activity in the Village. With this information Collins advised he approved twelve overtime shifts with approximately three to four officers working extra for drug/traffic enforcement to try and intercept the drugs. K9 Ori was deployed on all twelve shifts. The following are the statistics for the twelve deployments:
